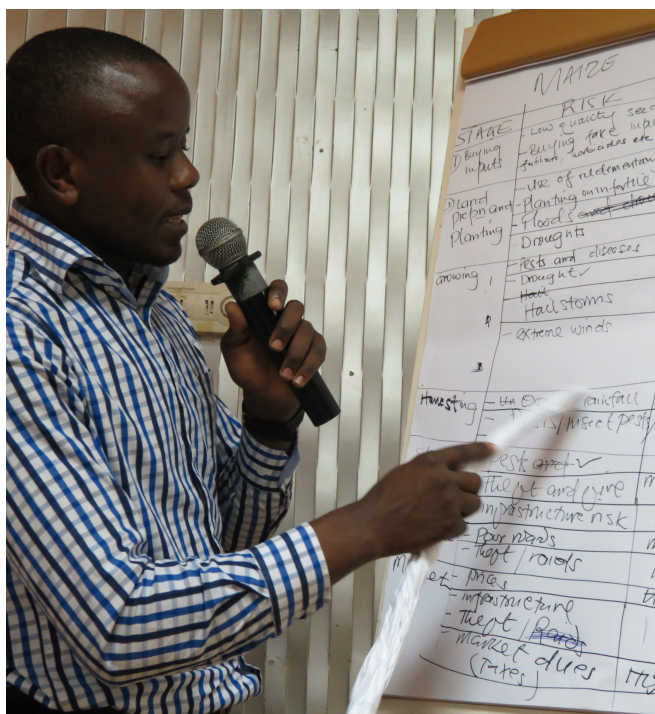

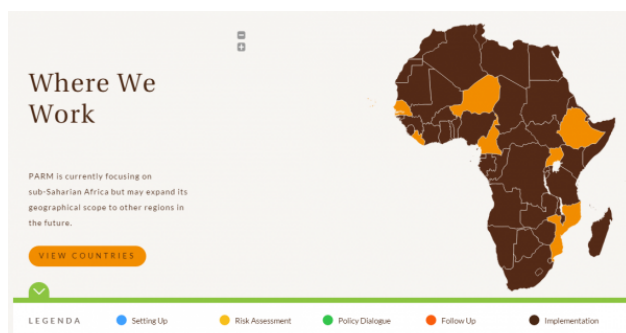
COMING UP

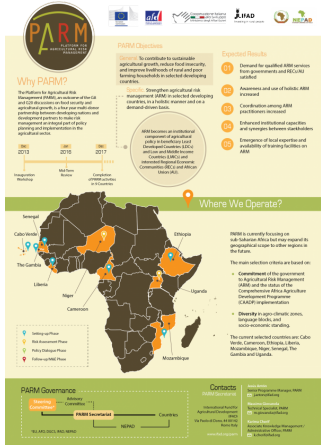
